Political Issues

Bahrain

1. Bahrain supports India-Pakistan talks

Tuesday, 16 February 2010

New Delhi: Bahrain which has friendly ties with India and Pakistan, welcomed their move to hold Foreign Secretary level talks on February 25. Minister of Foreign Affairs Khalid bin Ahmed bin Mohammed Al Khalifa observed that even if all issues were not covered, the two neighbours should 'engage and warm up' their relationship. He further stated that a serious commitment from both parties was essential and that terrorists and enemies of these countries were the beneficiaries of an impasse between India and Pakistan. The prospects of better bilateral relations between Bahrain and India had also been expressed by the Minister.

2. No Israelis hurt in India Blast

Saturday, 13 February 2010

At least nine people were killed and nearly 50 were injured in an explosion at the German Bakery in the western city of Pune. The café is located on the same street as the Pune Chabad House. The Chabad House director Rabbi Bezalel Kupchik said that no Israelis or Jews were in the bakery at the time of the blast and that there were no Jewish victims in the local hospitals.

3. 'We are not frightened, there is no anti-Semitism in India'

Monday, 15 February 2010

The terror bombing of German Bakery in the Indian city of Pune has rekindled concern for safety of Israelis and Jews in the subcontinent especially after the November 2008, Mumbai attacks. The bombing in Pune is believed to be the work of Pakistan based terrorist groups and it might have intended to include the Chabad House down the street from the bombed bakery. The Chabad House Director Rabbi Bezalel Kupchik believed that India was a country without any anti-Semitism and that a terrorist attack could happen anywhere. They also added that the bombing would not scare them away.

Kuwait: External Affairs Minister S M Krishna visited Kuwait to give an impetus to energy ties, foster closer relationship with the Gulf country and tap its surplus funds for India's infrastructure sector. Kuwait has been one of India's key energy suppliers. Krishna held talks with the Kuwaiti leaders to boost the ties and explored areas like joint production of fertilisers. Discussions also covered regional scenario in Pakistan and Afghanistan, developments in Iran, Iraq and Middle East Peace Process, reforms in UN Security Council.

New Delhi: Prime Minister Manmohan Singh met the visiting Palestinian President Mahmoud Abbas and discussed fresh efforts to initiate the Middle East peace process. The two sides exchanged views on Abbas' meeting with King Abdullah of Saudi Arabia late last year and the need for greater international effort to restart the Israeli-Palestinian talks.

Islamabad: Pakistan Prime Minister Yousuf Raza Gilani equated the Kashmir issue with the Palestine problem and claimed that peace would remain elusive in South Asia and the Middle East unless they are resolved. According to him, people of Palestine and Kashmir are fighting for their right of self determination. Gilani assured visiting Palestine President Mahmoud Abbas that Pakistan would continue to support the Palestinian people towards realizing their right of self-determination and sovereign state.

Turkey

8. Turkey agrees to work closely with India on global terrorism

Wednesday, 10 February 2010

New Delhi: India and Turkey unveiled a joint declaration on terrorism, wherein Ankara has agreed to recognize the need for the conclusion of India-initiated Comprehensive Convention on International Terrorism (CCIT). Both countries agreed to work towards developing an action plan with timelines and specific measures in tandem with existing structures like Joint Working Group against Terrorism.

The acquiescence of Turkey on CCIT is considered significant by India, because of Turkey's membership of the Organisation of Islamic Conference (OIC). India feels that the CCIT once adopted and finalised would be an important contribution against terrorism. Besides this, bilateral issues between the two countries and possibilities of a free trade agreement were discussed in the meetings Turkish President Abdullah Gul had with Prime Minister Manmohan Singh and External Affairs Minister S M Krishna.

Energy Issues

9. Can't wait indefinitely on pipeline project: Iran

Wednesday, 10 February 2010

New Delhi: Iran hoped that India would join the Iran-Pakistan-India pipeline project soon but pointed out that there should be time limits to arrive at a decision. Speaking to the journalists on the 31st anniversary of victory of Islamic Revolution Iran's Ambassador to India Syed Mehdi Nabizadeh said that the negotiations on IPI are still alive. He further pointed out that the discussions on the pipeline had been on for fifteen years and that Iran could not wait indefinitely.

India stopped attending trilateral meetings since 2007 and has not engaged with Iran bilaterally for over a year. The requirements from the Indian side are an Iranian guarantee of uninterrupted supply of gas via Pakistan and a stable pricing mechanism. Further, Nabizadeh expressed that important role India and Iran could play in stabilizing Afghanistan.

10. OIL-IOC combine launches hydrocarbon hunt in Libya

Kolkata: The consortium of Oil India Ltd and Indian Oil began drilling in five onshore blocks in Libya in January. They acquired the five exploratory blocks in Area 86 and 102 during bidding rounds in 2004 and 2005 respectively. Besides exploratory interests, the OIL-IOC duo has numerous non-operating interests in different places.

12. India-Arab trade to double by '14: Sharma

Tuesday, 9 February 2010

New Delhi: India has expressed hope that bilateral trade and investment ties between India and the Gulf region would double from the current turnover of US\$ 114 billion. Speaking at the Second India-Arab Investment Projects Conclave Minister of Commerce and Industry Anand Sharma exclaimed that based on India's high domestic consumption and demand, the economy is expected to grow by 7.5 percent this fiscal year. An early conclusion of the India – Gulf Cooperation Council Free Trade Agreement was advocated for by Shashi Tharoor, Minister of State for External Affairs, to boost bilateral economic engagement.

13. India, Israel to hold free-trade talks

Friday, 26 February 2010

India and Israel feel that the time is ripe to formalise trade. The sides are beginning negotiations on a free trade agreement. A new agreement would expand bilateral trade to commodities, investments and services rather than focusing only on certain sectors. Jyotiraditya Scindia, India's Minister of State for Commerce and Industry made these

observations following his meeting with Israeli President Shimon Peres in Jerusalem. Water technology, biotechnology and nanotechnology were identified as key areas in which collaboration could be expanded.

14. UAE investment house sells 13% in Spicejet

New Delhi: The UAE-based investment house Istithmar PJSC has sold most of its entire 13.39 percent holding worth Rs 1.690 billion in India's domestic carrier Spicejet. Istithmar still holds about \$12 million worth of foreign currency convertible bonds (FCCBs). The Dubai liquidity crunch was the prime reason for the company to sell its stakes.

He still faces threats

from fringe groups in the Hindu right. After Qatar had extended the citizenship offer, several of his fans and noted artists demanded that the Indian Government must facilitate his return.
