1. U.S. exempts India, eight others from sanctions for Iranian oil

Washington, Thursday, 6 June 2013

The US exempted India and eight other countries from sanctions for importing oil from Iran, noting that these countries have significantly reduced their dependence on Iranian oil in the last six months.
