1. India getting Saudi Exit visas for Nitaqat-hit emigrants

New Delhi, Monday, 1 July 2013

As the deadline for expatriates without valid work permits or employment in Saudi Arabia is set to end on 3 July under the Nitaqat labour law, the Indian government has made elaborate arrangements for their smooth exit as they have to leave the Kingdom before the expiry of the deadline.

2. 65,000 Indians in Saudi legally secure

Riyadh, Tuesday, 2 July 2013

There have been calls for an extension of the programme since a large number of applications are yet to be sorted, but no announcement has yet been made to this effect.

4. Iran asks India to settle all oil payment in rupees

New Delhi, Thursday, 11 July 2013

Iran has asked India to settle all oil trade payments including US\$1.53 billion owed to Tehran in partly convertible rupee as the sanctions-hit nation cannot find an alternative payment channel, industry and government sources in Delhi said.

5. Iran agrees to take all oil payments from India in rupees

New Delhi, Sunday, 14 July 2013

Iran has agreed to take oil trade payments from India in entirely rupees after US and western sanctions blocked all other payment routes. India has been, since July 2011, paying in Euros to clear 55 per cent of its purchases of Iranian oil through Ankara- based Halkbank. The remaining 45 per cent due amount was remitted in rupees in accounts of Iranian Oil Company opened in Kolkata-based UCO Bank.

12. India-Israel trade rises to US\$ 6 billion in 2012-13

Hyderabad, Sunday, 7 July 2013

Trade between India and Israel touched the US\$6 billion mark during 2012-13, up from US\$5.15 billion in 2011-12. Addressing a meeting hosted by the Federation of Andhra Pradesh Chambers of Commerce and Industry (FAPCCI) and Indo-Israel Chambers of Commerce and Industry, Jonathan Ben Zaken, Attaché - Economic and Commercial Affairs, Embassy of Israel, said trade volumes had grown to this level from a modest US\$ 200 million in 1992.
